Drug and Alcohol Testing

Staff wellbeing and public safety are the focus of the Police Drug and Alcohol Policy, which includes drug and alcohol testing across the organisation, with an emphasis on the health of our staff. All successful external applicants joining New Zealand Police are required to undergo pre-employment drug and alcohol testing. It will take the form of a breath test for alcohol and a urine test for drugs.

Police will pay for initial testing, but in the event of a non-negative result and the applicant still wishes to proceed with their application, they will be responsible for any costs associated with further laboratory testing. A non-negative or confirmed positive result, or refusal to consent to testing, will result in the application not continuing. All information will be handled sensitively and limited to those who need to know for the purposes of testing and application.
